



EXHIBITOR CONTRACT

Located at: Spiritwood Recreation Center, 305A 1st Street East.

I/We _____ of _____ (company)

hereinafter referred to as ("the Exhibitor"), hereby contract with Spiritwood Area Recreation, Culture and Sport Inc. (hereinafter referred to as "SARCS") to exhibit in their Spring 2019 Tradeshow (hereinafter referred to as "the Tradeshow"), taking place at the Spiritwood Recreation Complex on May 4th and 5th, 2019.

As consideration to participate in the Tradeshow, the Exhibitor acknowledges and agrees;

1. to pay an exhibitor registration fee of \$ _____ including GST (hereinafter referred to as "the Registration Fee"), which is to be paid to SARCS immediately upon registering;
2. that an administrative fee of \$50.00 will be retained by SARCS if the Exhibitor's registration is cancelled on or before April 5th, 2019, and that the Exhibitors full Registration Fee will be retained by SARCS if the Exhibitor's booking is cancelled after April 18th, 2019;
3. that in the event that the Spiritwood Rec Center, or any portion thereof, should be destroyed by fire or otherwise, or in any circumstances whatsoever occur which makes it impossible for SARCS to permit exhibitors to occupy the premises, the Exhibitor's rights to any damages whatsoever from SARCS shall be limited to a proportionate amount of the Registration Fee based on the time that the Rec Center is available to the Exhibitor during the Tradeshow;
4. that SARCS reserves the right to alter the exhibition floor plan or relocate exhibitors should SARCS or management of the Spiritwood Rec Center deem it necessary. In this regard, the Exhibitor acknowledges no promise have been made to the Exhibitor by SARCS regarding the Exhibitors booth location in the Tradeshow;
5. that SARCS does not guarantee exclusiveness of the Exhibitors product line or product type at the SARCS 2019 Spring Tradeshow.
6. that they shall not be permitted to sublet, trade or sell the space they have registered to exhibit in at the Tradeshow without written permission of SARCS;
7. optional extras may not be added to existing registrations after April 26th, 2019;
8. if required, the exhibitor will provide evidence of property and liability insurance in respect to his/her participation in the Tradeshow;
9. that SARCS has no liability whatsoever for damage to or loss of the Exhibitors property that is at the Tradeshow;
10. that the Exhibitors property is displayed at their own risk and they assume all responsibility for loss or damage to his/her property due to fire, theft, flood, lightening, natural disaster, explosion or any other cause whatsoever. The Exhibitors specifically acknowledges that SARCS assumes no responsibility whatsoever for loss or damage of the Exhibitors property;
11. to assume personal responsibility for, and hold SARCS harmless from, any expensed or liability whatsoever that the Exhibitor causes that results in any injury or damage to the Exhibitor and/ or their property, and any part of the facility, whether it occurs inside the Rec Center or on their grounds thereof;
12. to completely assemble their exhibit inside the Rec Center at the space designated by SARCS during the hours as specified on the Registration Form;
13. to not dismantle their display or remove their goods from the Rec Center until 4:00pm on the last day of the Tradeshow, early departure will result in a \$50.00 penalty and the loss of booth selection for 2020;
14. in the event that the Exhibitor fails to remove their exhibit and property from the Rec Center during the final move out time, specifically 4:00pm on the last day of the Tradeshow, the Exhibitor agrees to pay SARCS \$50.00 to remove the Exhibitors property from the Rec Center as well as \$10.00/day for storage fees;
15. to keep their exhibit in a neat and clean condition during the tradeshow, and to remove all garbage and items brought to their designated exhibit area by the closing hours of the last day of the Tradeshow, failure to remove all garbage may result in a \$50.00 penalty fee.
16. to do nothing to deter from the good character of the Tradeshow;
17. to abide by all of the facility rules and regulations as posted in the facility, and as informed by employees of the facility.
